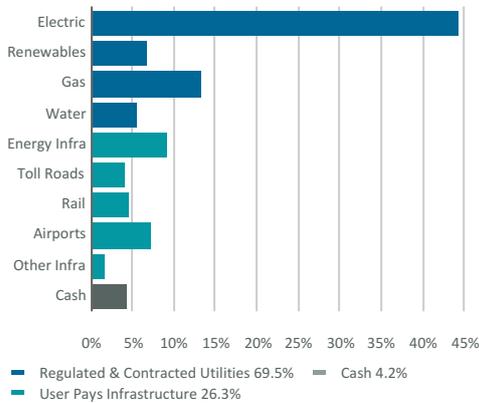

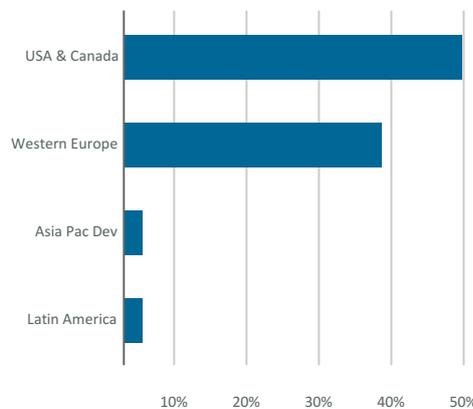

REGIONAL BREAKDOWN

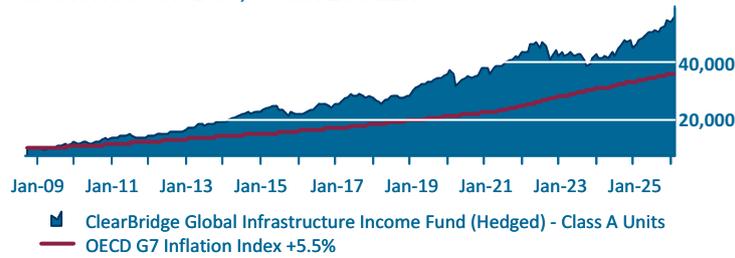
