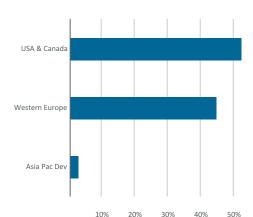
**REGIONAL BREAKDOWN**

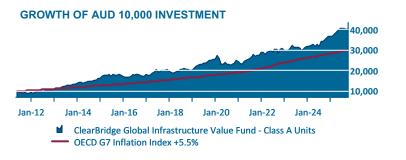

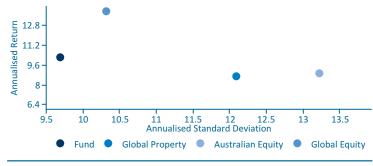
